

## APPLICATION TO LEASE AN iPad.

### About our iPad Program

We are conscious at St Joseph's School that we are preparing children for a successful future and for jobs which are currently unknown. What is certain however, is that technology will continue to play an important role for lifelong learners.

At St Joseph's School we believe all children require excellent access to technology so that they can resource, create and present their own authentic learning. The leased iPad can be used at school and at home (with a Responsible Care Agreement).



The iPad will access the internet and the school network via wireless network points allocated around the school. The iPad will have the latest multi-media software programs used at St Joseph's School, is covered by the school insurance (subject to terms and conditions) and have a three-year guarantee by Apple Computers. The iPad is light and compact, making it very durable. There will be an extra level of protection for the iPad with the inclusion of a protective case and screen.

Please note that only MacBooks/iPads owned by the school are permitted to access the school network to ensure that children have access to the best security, the latest software and reliable hardware and fast network speed. This enables teachers to focus on their teaching rather than trying to sort out technical problems and capabilities with unknown devices.

Reception to Year 3 classes are still provided with multiple iPads to be shared by the students in the classroom.

## Agreement to Lease an iPad from St Joseph's School Payneham

Please complete the following if you will be leasing an iPad.

- I will notify the school immediately if the iPad is not in working order.
- I will notify the school immediately of any damage caused to the iPad.
- I will ensure that my child takes due care to protect the machine by ensuring that they carry the iPad appropriately.
- I will not attempt to repair or have the iPad repaired.
- I will return the iPad to the school at any time it is requested for updating or maintenance.
- If your child is leaving school, I will return the iPad one week prior to the final day.
- Please ensure the iPad, charger and accessories are all returned in good clean condition to the school. Failure to return on time will result in an extra month being invoiced.
- The iPad and accessories must be returned in good working order and the health-check by an Apple technician be approved or fees may be charged.
- The protective cover is NOT to be removed or tampered.
- Should the protective cover be damaged, you will be invoiced at full replacement cost.
- In the event that an iPad requires repair due to accidental damage or misuse, an amount of \$100 insurance excess will be charged to the family.
- iPad chargers are NOT to be brought to school.
- Damage to chargers will be invoiced the replacement cost of the charger unless covered under the warranty.
- I understand that I will either pay the lease amount upfront, or make three instalments via direct debit, on the allocated dates indicated.
- Failure to pay may result in the iPad being returned to the school.
- The iPads are NOT covered under insurance outside of Australia. iPads under this agreement are NOT allowed to leave Australia.
- iPad will need to be brought to school each day fully charged. A replacement device may not be provided on the day.

The package includes an iPad, charger, keyboard, protective cover, carry case and screen protector.
